Polasaí Caomnú Leanaí den Chumann Scoil drámaíochta

Glacann an Cumann Scoil drámaíochta leis go bhfuil fiorthábhacht le cosaint leanaí agus leas leanaí maidir le gach gné de ghnóan chumainn agus nach mór sin a bheith le sonrú ar pholasaithe, modhanna oibre agus beartaíocht uile an Chumainn. Dá réir sin, ag teacht lena n-éilítear faoi 'Nósanna Imeachta maidir le Cosaint Leanaí i mBunscoileanna agus i Scoileanna Iarbhuscoile' na Roinne Oideachais agus Scileanna, tá an polasaí seo a leanas maidir le cosaint leanaí aontaithe ag an Cumann Scoil drámaíochta:

1. Tá glactha ag an gCumann Scoil drámaíochta le 'Nósanna Imeachta maidir le Cosaint Leanaí i mBunscoileanna agus i Scoileanna Iarbhuscoile' na Roinne, maraon leis an 6 aguisín a ghabhann leis an gcáipéis, agus déanfar a gcur i bhfeidhm go hiomlán, gan athrú gan leasú, mar chuid den pholasaí ginearálta maidir le cosaint leanaí.
2. An Duine Idirchaidrimh Ainmnithe (DIA): BRÍD MHAIC GEARAILT
3. An Leas-Dhuine Idirchaidrimh Ainmnithe (Leas-DIA): TOMÁS Ó MURCHU
4. I ndáil le polasaithe, modhanna oibre agus beartaíocht de chuid an Chumainn Scoil drámaíochta, cloífear leis na prionsabail seo a leanas den dea-chleachtas maidir le cosaint leanaí agus leas leanaí:
Déanfaidh an Cumann Scoil drámaíochta
 - glacadh leis go bhfuil fiorthábhacht le cosaint leanaí agus leas leanaí, gan bheann ar aon cheist eile;
 - comhoibriú go hiomlán leis na húdaráis chuí faoin reachtaíocht maidir le cosaint leanaí agus cúrsaí leasa leanaí
 - gnásanna sábháilte a ghlacadh chuici féin d'fhonn an dóigh go dtarlódh dochar nó tionóisc do leanbh a mhaolú oiread agus is féidir agus an lucht oibre a chosaint ó chall dul i mbaol nach gá a bhféadfadh gurb é toradh a bheadh air go gcuirfí drochúsáid nó faillí ina leith;
 - gnás ionracais a thabhairt chun cinn le tuismitheoirí agus iad a spreagadh a bheith rannpháirteach in oideachas a gcuid leanaí; agus
 - meas iomlán a léiriú ar riachtanais rúndachta agus í ag déileáil le cúrsaí caomhnaithe leanaíCloífidh an cumann leis na prionsabail thuas freisin i ndáil le haon dalta fásta lena mbaineann soghontacht speisialta.
5. Ba cheart an chuid seo den pholasaí maidir le cosaint leanaí a úsáid chun tagairt go sonrach do pholasaithe, do chleachtais agus do ghníomhaíochtaí de chuid na scoile a meastar go mbaineann siad go mór le cosaint leanaí (e.g. **an Prótacal Cosaint Leanaí**, etc.)
Tá sé cinntithe ag an gCumann Scoil drámaíochta go bhfuil na polasaithe, prótacail nó cleachtais, de réir mar is cuí, curtha i bhfeidhm i ndáil le gach ceann de na rudaí thuasluaite.
6. Tá teacht ar an bpolasaí seo ar shuíomh Idirlín an Chumainn Scoil drámaíochta.
7. Déanfaidh an Cumann Scoil drámaíochta an polasaí seo a thabhairt faoi athbhreithniú uair in aghaidh na scoilbhliana.

Child Protection Policy

Underlying Principle

Each and every drama troupe, participating in drama festivals of An Cumann Scoil Dramaíochta or attending other events that An Cumann Scoil Dramaíochta organises from time to time, does so under its own Child protection policy.

Child Protection Policy - An Cumann Scoil Dramaíochta

An Cumann Scoil Dramaíochta recognises that child protection and welfare considerations permeate all aspects of An Cumann Scoil Dramaíochta and must be reflected in all of the Cumann's policies, practices and activities. Accordingly, in accordance with the requirements of the Department of Education and Skills' Child Protection Procedures for Primary and Post Primary Schools, An Cumann Scoil Dramaíochta has agreed the following child protection policy:

1. An Cumann Scoil Dramaíochta has adopted and will implement fully and without modification the Department's Child Protection Procedures for Primary and Post Primary Schools, including all 6 appendices attached to the document, as part of this overall child protection policy.
2. The Designated Liaison Person (DLP) is Brid Mhic Gearailt
3. The Deputy Designated Liaison Person (Deputy DLP) is TOMÁS Ó MURCHU
4. In its policies, practices and activities, An Cumann Scoil Dramaíochta will adhere to the following principles of best practice in child protection and welfare:
An Cumann Scoil Dramaíochta will
 - recognise that the protection and welfare of children is of paramount importance, regardless of all other considerations;
 - fully co-operate with the relevant statutory authorities in relation to child protection and welfare matters
 - adopt safe practices to minimise the possibility of harm or accidents happening to children and protect workers from the necessity to take unnecessary risks that may leave themselves open to accusations of abuse or neglect;
 - develop a practice of openness with parents and encourage parental involvement in the education of their children; and
 - fully respect confidentiality requirements in dealing with child protection matters.

The school will also adhere to the above principles in relation to any adult pupil with a special vulnerability.
